# November 14, 2017

Dr. Hughes called the Board meeting to order at 5:16 p.m. Minutes of the September 19, 2017 were approved as corrected.

## **COMMITTEE REPORTS**

Budget and Finance Committee -

**RESOLUTION 1117-01:** Ratifies the payment of bills for the month of September 2017.

**RESOLUTION 1117-02:** Ratifies the payment of bills for the month of October 2017.

Mr. Long made a motion to approve, Mr. Reiff seconded. Motion carried, resolution adopted.

Mrs. Sidener discussed 2017 budget and areas that support 2018 budget. Mrs. Sidener reviewed relationship between placements and IV-E reimbursements. Ms. Provaznik reported the Board Finance Committee met twice for budget review. She noted placements and the work required to meet each individual child's needs.

Ms. Scanland advised when a child is in need of a specific placement to address special needs that risk and safety are first priority. Relative placements are sought first. Agency responsible for provision of education to community and community partners in regard to the need for placement and reunification.

- The agency was asked to present to Public Children Services Association of Ohio conference, in regards to our involvement with the high profile case impact on the agency and resulting legislative fix. Review of the Bill provided.
- Adopt A Family: If any board member would like to donate to support a family.
- Cole Collection is a fundraising event that provides all children in our temporary custody and the temporary custody of relatives, with a Christmas gift. This is now in its fourth year. This year we connected Cole Collection with the Child's Developmental Center to purchase 122 Christmas reading bags for kinship families for an addition to the gifts received from Cole Collection. Bags contained 24 individually wrapped Christmas books. This partnership helped raise a significant amount of money for the Children's Developmental Center and provide a wonderful gift for children involved with the agency.

- Agency works closely with our Wendy's Wonderful Kids recruiter to place many of the children we have in our permanent custody.
- We have finalized 84 adoptions since July 2012, though the end of 2018, possible finalization of 103 adoptions.
- We currently have 24 children available for adoption.
- In 2017 there will be 25 adoptions finalized.
- In 2018 there will be a possible 19 adoptions.
- 94 percent of the adoptions that have occurred since July 2012 have been in Agency foster homes.
